**DIRECTIONS TO SITE:** From I-69 take exit 241 and go east on HWY 332 (becomes McGalliard Road) approximately 9 miles to Walnut Avenue. There is an Aldi's/BP/Walgreens at the intersection. Go south to next stop light that is the intersection with Centennial Avenue. Turn left (east) and MOTC is the first driveway on the left (north side) after the big white block warehouse.

**Crating:** Limited space for entered dogs only. No ex-pens allowed in the building. Please observe marked crating locations.

**Food:** MOTC will be offering homemade breakfast and lunch items, snacks, and drinks for a free will offering. All proceeds will benefit the MOTC Building Fund.

## EXHIBITOR INFORMATION

All dogs must be on a short leash and under control while on trial grounds except while showing. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head- halter types, are allowed. Dogs MUST run "naked," without a collar/harness. Collars/harnesses which can be easily and quickly removed and replaced are strongly encouraged. NO flexi-leads allowed.

**CHECK IN - REGISTRATION:** Building will open at 11:00 am on Friday, 12/7 and 7:45 am on Sat 12/8 and Sun 12/9, 2018. General briefing will be at 11:45 pm on Friday (subject to change-final times will be published in the Welcome letter) and 8:15 am on Saturday and Sunday. Judge's briefing will be at 11:50 am on Friday (subject to change-final times will be published in Welcome letter), 8:20 am on Saturday and Sunday. **First run for Trial 1 will be no later than 12:00 pm on Friday and 8:30 am on Saturday and Sunday.** Classes will run Crazy 8s Trial 1, Crazy 8s Trial 2, Master Trial 1, Master Trial 2 on Friday and Instinct, Novice Trial 1, Novice Trial 2, Open Trial 1, Open Trial 2, Crazy 8s Trial 1, Senior Trial 1, Senior Trial 2, Master Trial 1, Master Trial 2 on Saturday and Sunday. A judging schedule will be sent via email after entries close. If you do not have email, please enclose a stamped self-addressed envelope.

### HEIGHT DIVISIONS:

Dogs 13" and under, **Small**; Dogs 13.1 to 18", **Medium**;  
Dogs over 18", **Large**

**RUNNING ORDER: Small to Large.** Dogs will be run in height order with dogs being handled by the same person separated into different staged groups.

Entries cannot be accepted, canceled, altered or substituted after the entries have closed.

- **No entry** will be accepted which carries any conditions regarding its acceptance.
- **Declination of Entries.** The Muncie Obedience Training Club, Inc., may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other cause and

no one shall have any claim or recourse against the Muncie Obedience Training Club, Inc. or any official thereof.

- **Errors on Entry Blanks.** Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.
- **Returned Checks do not constitute a valid entry fee.** The TRIAL SECRETARY will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.
- **REFUNDS** — There will be no refunds for absent entries. Refunds will be made for withdrawn entries only if request is made prior to closing date.
- **If because of riots,** civil disturbances or other acts beyond the control of MOTC, it is impossible to open or to complete the show, no refund or entry fee will be made. MOTC will not be responsible for loss or damage to property while on show site.
- **Judges are not required to wait for dogs.** The owner or handler of each dog is solely responsible for having it ready when its class is to be judged.
- **Vehicles parked contrary** to regulations will be subject to towing at owner's expense.
- **All Handlers must pick up after their dogs.** Anyone witnessed not cleaning up after their dogs will be requested to leave and no refunds given.
- **The show site will open** one hour prior to the start of the event and will close one hour after the event.
- **All dogs must be kept on leash** or crated at all times, except as allowed in the Show ring. NO FLEXI LEADS allowed inside the building.
  - **No smoking in buildings** or within 10 feet of buildings ("reasonable distance" per county code).
- **Exhibitors should follow their veterinarians' recommendation** to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial.** Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

**Move-Ups:** Forms will be available at the Secretary's table. Previous trial move ups must be submitted no later than 6:00 pm 11/26/18 via email or mail. Same day move ups must be submitted no later than 30 minutes before the start of the next trial. Next day move ups must be submitted by end of trials on Saturday.

**Awards:** Qualifying ribbons will be awarded for all qualifiers in all classes, including Instinct and Crazy 8s. Placement ribbons will be awarded for 1st through 4th place in Novice, Open, Senior and Master classes in each height division. New title rosettes will be awarded to those who obtain a new title in Novice, Open, Senior, Master and Crazy 8s. A special rosette will be awarded to those who earn a RATCH\* or higher.

**\*\*NEW\*\*A special rosette and prize will be awarded for any Master Entry that has a perfect weekend, qualifying all six times in Master.**

*\*If you anticipate earning a RATCH at our trial, please let us know so that we have your special prize available.*

**Facility:** The ring is located indoors on foam padding over concrete. The blind is 10' x 10', located in the northeast corner of the building. The blind surface is tile.
